

## **Vacations Hawaii Baggage Fee/ Allowance Policy**

**Effective April 1, 2018**

**Carry-on Baggage** Each passenger may bring a maximum of one carry-on item on board the aircraft free of charge, subject to space availability. All carry-on baggage must be retained in the participant's custody and stored under a seat or in an overhead compartment. Carry-on baggage may not exceed a maximum outside linear dimension of 45 inches or a maximum weight of 25 pounds. If adequate space is not available, Vacations-Hawaii may require that the carry-on baggage be checked.

In addition to the carry-on baggage described above, participants may carry on one personal item, such as a purse, briefcase, laptop computer, camera case, or diaper bag. Qualified persons with disabilities may also carry on or check free of charge personal assistive devices, such as wheelchairs (stowed in the aircraft cabin subject to space availability), crutches, and medical supplies or equipment.

**Checked Baggage:** The following will apply to all checked baggage:

- 1) Participants traveling in first class will be allowed two pieces of checked luggage at no charge except that oversized or overweight items may be subject to the fees described below.
- 2) All other participants will be charged a fee of \$25 for the first piece and \$25 for the second piece of checked luggage on each flight segment.
- 3) Participants checking more than two pieces of luggage will be charged \$100 per piece for each such additional item of checked baggage on each flight segment.
- 4) In addition to the checked baggage fees set forth above, Vacations-Hawaii may, in its sole discretion, accept oversized or overweight items as checked baggage when space is available, subject to the payment of a fee of \$100 per piece on each flight segment. Checked baggage that exceeds a maximum outside linear dimension of 62 inches constitutes oversized baggage, and checked baggage that exceeds a maximum weight of 50 pounds constitutes overweight baggage. Items heavier than 70 pounds will not be accepted for transportation.

In addition to the fees described above, if you travel on a connecting flight, the airline operating such flight may charge you for the transportation of checked baggage according to that airline's baggage fee policy. See the website of the airline operating your connecting flight for more information on the applicable baggage fees for those flight segments. For inter-island connecting flights within the State of Hawaii, Vacations-Hawaii will collect the applicable baggage fee only for the flight segments on which the baggage is checked in with Vacations-Hawaii.

**Luggage Liability Limitation:** Please be aware that Omni Air International assumes no liability for fragile or perishable articles or responsibility for damage to or loss of items including, but not limited to the following: Garment bags, backpacks, boxes, sporting and recreational equipment, musical instruments, car/infant seats, strollers, money, liquor, jewelry, eyeglasses, medication, mechanical, electronic, video, audio and or mechanical equipment, works of art or other valuables. If you are traveling with these or other items of value, it is suggested that you pack them in your carryon luggage.

**Please note:** Luggage is designed to protect its contents. In the course of normal handling luggage will acquire evidence of use such as minor cuts, scratches, dents or soil. We trust you will understand that Omni Air international is not responsible for this type of damage or any of the following: Broken feet or wheels, damage to overpacked bags, damage to pull handles, lost pull straps, zipper damage, damage to items of a fragile or perishable nature or manufacturers defects.

**Hazardous materials:** Federal law prohibits the carriage of certain hazardous materials such as aerosols, fireworks and flammable liquids aboard the aircraft. **Electronic cigarettes:** Electronic cigarettes (e-cigs) may never be used on the airplane or during flight. In addition, electronic cigarettes are prohibited from being transported in checked luggage but may be transported in carryon luggage.

**Prohibition on firearms and ammunition:** Vacations Hawaii prohibits the carriage of any firearms, firearm parts, and/or ammunition onboard the aircraft, either as carry-on items in the aircraft cabin or as checked baggage. Passengers attempting to bring such items for transportation onboard their flight will be denied boarding, their tour package will be canceled in accordance with Vacations Hawaii's Cancellation Policy and they will be ineligible for any refund. In addition, FAA and TSA regulations regarding the carriage of firearms and ammunition onboard aircraft apply.
