

**Valley Forge Casino Resort  
Boyd Points Promotional Terms  
April 2022**

Overview

Sapphire Boyd Rewards Loyalty Members and above are eligible to earn spendable Boyd Points. Boyd Point earning is based on individual play at participating Boyd Gaming properties and Stardust Online Casino.

Boyd Points can be redeemed throughout the property for retail, food, and free slot play.

1,000 Boyd Points = \$1 Free Slot Play  
1,000 Boyd Points = \$1 for Hotel or Retail  
600 Boyd Points = \$1 for Food Outlets

Boyd Points can be redeemed online through Boyd Rewards Online (BCO) for Stardust Casino Site Credit to use at the Stardust Online Casino.

1,000 Boyd Points= \$1 Stardust Casino Site Credit

In order to redeem their Boyd Points for Stardust Casino Site Credits, guests must have a minimum of 10,000 (ten thousand) Boyd Points which may be redeemed for \$10 Stardust Casino Site Credits.

A maximum of 1,000,000 (one million) Boyd Points may be redeemed for Stardust Casino Site Credits daily. The maximum number of Boyd Points that a guest may redeem for Stardust Casino Site Credit at Stardust Online Casino is 5,000,000 (five million) per month.

Guests whose yearly status is renewed at Ruby will retain any non-expired Boyd Points that they had previously earned.

Guests are responsible for ensuring that their Boyd Point redemptions during this processing time do not cause their account to become overdrawn. Management reserves the right to prohibit guests from debiting their Boyd Point balance for Stardust Casino Site Credits if one is found to be fraudulently redeeming Boyd Points.

Boyd Points that are earned through in-app purchases on Stardust Social Casino may take up to 48 hours to reflect in an individual's Boyd Rewards account.

Emerald, Onyx, and Titanium guests have until July 31, 2022 to keep their account active and ensure that their Boyd Points do not expire. Select Sapphire guests who have a Boyd Point balance of 50,000 or more will also have until July 31, 2022 to play at any Boyd Rewards destination to keep their account active and ensure their Boyd Points do not expire.

Points expire after six (6) months of card inactivity. Inactivity is measured by carded play at physical Boyd Rewards retail locations. Play at Stardust Online Casino does not contribute to activity.

All guests from Hawaii are excluded as well as Emerald + guests from Canada will be excluded from inactivity point expirations and have until December 31, 2022 to return to a Boyd Rewards property to keep their point balances active.

Throughout the event, Management will ensure that functions are working properly; computer malfunction will void entries/points.

Employees of Valley Forge Casino Resort, its related companies, affiliates and subsidiaries, as well as their spouse, children, parents, siblings and anyone living in their household, are not eligible to participate.
